ER at Fruitville Opens December 1st

Lakewood Ranch Medical Center's new Freestanding Emergency Department, ER at Fruitville, will begin operations on Tuesday, December 1. As a physician who takes ER call at the main hospital, you may also now receive a call from the FED.

For those that have not worked with an FED in past, it is treated as an extension of the Main Hospital ER. It is staffed 24/7 with an ER Physician and full complement of nursing, imaging, and laboratory. All EMTALA and federal/state regulations apply. If a specialist oncall is needed for a patient, the FED would call you, just as they would from the Main Hospital ER. If a patient needs to be physically examined by an on-call physician, the patient may be transferred to the Main Hospital ER or admitted directly from the FED. There are limited modalities at the FED for treatment, so any surgical intervention, advanced diagnostic testing (anything above a CT, X-ray, or Ultrasound), etc. will be performed at the Main Hospital.




P&T Committee - Formulary Changes

Therapeutic Interchanges

UHS corporate performed a large clinical review of the entire automatic therapeutic interchange list used throughout all UHS hospitals and made recommendations to implement moving forward. In conjunction, LWRMC reviewed the proposed interchanges based on their equivalent therapeutic dosing efficacy, safety, adverse drug reactions and pricing. These changes were approved to update as presented.

Policy and procedures

- Dobutamine Stress Echocardiogram
 - This policy was up for review and revised based on available evidence, standards and accreditation requirements.
 - The purpose of the policy is to establish procedural steps and promote safety during a dobutamine stress echocardiogram procedure.
- Regadenoson Nuclear Stress Test
 - This policy was up for review and revised to provide up-to-date guidelines and promote safety.
 - The purpose of the policy is to establish general guidelines and procedural steps for all LWRMC Registered Nurses (RN's) and medical staff participating in a Regadenoson Nuclear Stress Test.

"PM Collection"

The "PM Collection" is a great tool to use to ensure test results are complete and in the chart for the Early Discharge Patients. When placing a Lab Test Order for an "Early Discharge" patient, select "PM Collection" as the test priority.

- PM Collection is established as a TIMED collection in Cerner. Specimen collection will occur at 21:00
- PM Collection allows the phlebotomist to plan ahead for collection
- PM Collection improves collection workflow by removing the collection time from the volume of the AM collection run
- PM Collection helps ensure the results are in the patients chart when the physician rounds early the next morning
